Sets forth the rule for consideration of H.R. 2693 (Popcorn Workers Lung Disease Prevention Act).

Actions Timeline

- **Sep 26, 2007:** Considered as privileged matter. (consideration: CR H10908-10910)
- **Sep 26, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 678.
- **Sep 26, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 678, Ms. Sutton moved the previous question and by voice vote, the Chair announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays which were ordered and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.

- **Sep 26, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 221 - 193 (Roll no. 909). (consideration: CR H10910, H10912-10913)
- **Sep 26, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H10908)
- **Sep 26, 2007:** On agreeing to the resolution Agreed to by voice vote. (text: CR H10908)
- **Sep 26, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 25, 2007:** Introduced in House
- **Sep 25, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-349, by Ms. Sutton.
