Healthy Forests Restoration Amendments Act of 2008 - Amends the Healthy Forests Restoration Act of 2003 to revise requirements with respect to the areas of federal land on which authorized hazardous fuel reduction projects may be conducted.

Actions Timeline

- **Oct 3, 2008:** Referred to the Subcommittee on Department Operations, Oversight, Nutrition and Forestry.
- **Aug 8, 2008:** Referred to the Subcommittee on National Parks, Forests and Public Lands.
- **Aug 1, 2008:** Introduced in House
- **Aug 1, 2008:** Referred to the Committee on Agriculture, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
