Condemns all attacks upon the memory of veterans and their service to the United States, as exemplified by the incident of vandalism of September 7, 2007, (at the Vietnam Veterans War Memorial, Washington, D.C.).

Actions Timeline

- **Oct 23, 2007:** Mr. Filner moved to suspend the rules and agree to the resolution.

- **Oct 23, 2007:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 680.
