Sets forth the rule for consideration of H.R. 3648 (Mortgage Forgiveness Debt Relief Act of 2007).

Actions Timeline

- **Oct 4, 2007:** Considered as privileged matter. (consideration: CR H11255-11259)
- **Oct 4, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 703.
- **Oct 4, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 703, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Mr. Lincoln-Diaz Balart(FL) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
