Job Creation and Unemployment Relief Act of 2008 - Makes supplemental appropriations for FY2009 for infrastructure investments for: (1) transportation to the Department of Transportation (DOT); (2) clean water to the Environmental Protection Agency (EPA); (3) flood control and water resources to the Department of Defense (DOD) - Civil for the Department of the Army Corps of Engineers and the Department of the Interior Bureau of Reclamation; (4) for 21st century green high-performing public school facilities to the Department of Education; (5) for public and Indian housing and the Public Housing Capital Fund to the Department of Housing and Urban Development (HUD); (7) energy development to the Department of Energy (DOE); and (8) the Department of Labor (DOL), Employment and Training Administration, for job training and employment services, as well as state unemployment insurance and employment service operations.

Amends the Supplemental Appropriations Act, 2008 to increase and extend unemployment compensation (UC).

Prescribes: (1) a temporary increase in the federal medical assistance percentage (FMAP) title XIX (Medicaid) of the Social Security Act; and (2) an adjustment in computation of Medicaid FMAP to disregard an extraordinary employer pension contribution.

Makes appropriations for FY2009 to the Secretary of Agriculture to provide a temporary increase in benefits under the Supplemental Nutrition Assistance Program.

- **Sep 26, 2008:** Referred to the House Committee on Appropriations.
- **Sep 26, 2008:** Rule H. Res. 1507 passed House.
