Summary (as of Oct 10, 2007)

Sets forth the rule for consideration of H.R. 2895 (National Affordable Housing Trust Fund Act of 2007).

Actions Timeline

- **Oct 10, 2007:** Considered as privileged matter. (consideration: CR H11410-11412)
- **Oct 10, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 720.
- **Oct 10, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 720, the Chair put the question of ordering the previous question and by voice vote, announced the ayes had prevailed. Mr. Hastings (WA) objected to the voice vote based upon the absence of a quorum. The Chair postponed further proceedings on the question of adoption of ordering the previous question until later in the legislative day. The point of no quorum is considered as withdrawn.
- **Oct 10, 2007:** Considered as unfinished business. (consideration: CR H11412-11413)
- **Oct 10, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 223 - 195 (Roll no. 951). (consideration: CR H11412-11413)
- **Oct 10, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 224 - 194 (Roll no. 952).(text: CR H11410)
- **Oct 10, 2007:** On agreeing to the resolution Agreed to by recorded vote: 224 - 194 (Roll no. 952). (text: CR H11410)
- **Oct 10, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Oct 9, 2007:** Introduced in House
- **Oct 9, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-369, by Ms. Castor.
- **Oct 9, 2007:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Financial Service now printed in the bill.
- **Oct 9, 2007:** Placed on the House Calendar, Calendar No. 132.
