Summary (as of Oct 25, 2007)

Sets forth the rule for consideration of H.R. 3963 (Children's Health Insurance Program Reauthorization Act of 2007).

Actions Timeline

- **Oct 25, 2007:** By direction of the Committee on Rules, Mrs. Slaughter called up H. Res. 774 and asked for its immediate consideration.
- **Oct 25, 2007:** POINT OF ORDER - Mr. Sessions stated that the provisions of H. Res. 774 contain a waiver which violated the Budget Act. The Chair announced that the necessary threshold had been met which requires that the specific language objected to be identified. Pursuant to the rule, the House proceeded with 10 minutes of debate on the question of consideration of the resolution.
- **Oct 25, 2007:** On motion to consider the resolution Agreed to by the Yeas and Nays: 216 - 181 (Roll no. 1003). (consideration: CR H12027-12029)
- **Oct 25, 2007:** Mr. Price (GA) moved to reconsider the vote.
- **Oct 25, 2007:** Ms. Slaughter moved to table the motion to reconsider. (consideration: CR H12029-12030)
- **Oct 25, 2007:** On motion to table the motion to reconsider Agreed to by recorded vote: 218 - 183 (Roll no. 1004).
- **Oct 25, 2007:** Considered as privileged matter. (consideration: CR H12031-12042)
- **Oct 25, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 774.
- **Oct 25, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 221 - 188 (Roll no. 1006). (consideration: CR H12040-12041)
- **Oct 25, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 215 - 187 (Roll no. 1007). (text: CR H12027)
- **Oct 25, 2007:** On agreeing to the resolution Agreed to by the Yeas and Nays: 215 - 187 (Roll no. 1007). (text: CR H12027)
- **Oct 25, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Oct 24, 2007:** Introduced in House
- **Oct 24, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-408, by Ms. Slaughter.
- **Oct 24, 2007:** Rule provides for consideration of H.R. 3963 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit. Measure will be considered read. Bill is closed to amendments.
- **Oct 24, 2007:** Placed on the House Calendar, Calendar No. 141.
