African Health Capacity Investment Act of 2007 - Amends the Foreign Assistance Act of 1961 to authorize the President to provide assistance, including through international or nongovernmental organizations, for programs to improve human health care capacity in sub-Saharan Africa.

Directs the President to develop and transmit to the appropriate congressional committees a strategy for coordinating, implementing, and monitoring assistance programs for human health care capacity in sub-Saharan Africa.

Authorizes FY2008-FY2010 appropriations.

- Oct 9, 2007: Placed on Senate Legislative Calendar under General Orders. Calendar No. 414.
- Sep 11, 2007: Committee on Foreign Relations. Ordered to be reported with amendments favorably.
- Mar 7, 2007: Introduced in Senate
