Waives points of order against consideration of the conference report on H.R. 3222 (Department of Defense Appropriations Act, 2008).

Actions Timeline

- **Nov 8, 2007:** By direction of the Committee on Rules, Ms. Slaughter called up H.Res. 806 and asked for its immediate consideration. (consideration: CR H13311-13321)
- **Nov 8, 2007:** POINT OF ORDER - Mr. Flake raised a point of order against the provisions of H.Res. 806 because it waived all point of order against the conference report to accompany H.R. 3222. The Chair announced that the disposition of the point of order would be resolved by the question of consideration of H.Res. 806. The House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration.
- **Nov 8, 2007:** Will the House now consider the resolution Agreed to by the Yeas and Nays: 220 - 191 (Roll no. 1061).
- **Nov 8, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 806.
- **Nov 8, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 217 - 196 (Roll no. 1062). (consideration: CR H13319-13320)
- **Nov 8, 2007:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 226 - 184 (Roll no. 1063).(text: CR H13312)
- **Nov 8, 2007:** On agreeing to the resolution Agreed to by recorded vote: 226 - 184 (Roll no. 1063). (text: CR H13312)
- **Nov 8, 2007:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 7, 2007:** Introduced in House
- **Nov 7, 2007:** The House Committee on Rules reported an original measure, H. Rept. 110-435, by Ms. Slaughter.
- **Nov 7, 2007:** All points of order against the conference report and against consideration are waived. The conference report shall be considered as read.
