Summary (as of Apr 10, 2008)

Southern Nevada Readiness Center Act - Permits Clark County, Nevada, to convey approximately 51 acres of land in Clark County to the Nevada Division of State Lands for use by the Nevada National Guard.

Provides for the reversion of such land to Clark County for management in accordance with the Southern Nevada Public Land Management Act of 1998 if it ceases to be used by the Nevada National Guard.

- Jan 30, 2008: Committee on Energy and Natural Resources. Ordered to be reported with an amendment in the nature of a substitute favorably.
- Sep 20, 2007: Committee on Energy and Natural Resources Senate Subcommittee on Public Lands and Forests. Hearings held. With printed Hearing: S.Hrg. 110-216.
- Apr 18, 2007: Received in the Senate and Read twice and referred to the Committee on Energy and Natural Resources.
- Apr 17, 2007: Mr. Grijalva moved to suspend the rules and pass the bill.
- Apr 17, 2007: Considered under suspension of the rules. (consideration: CR H3414-3415)
- Apr 17, 2007: DEBATE The House proceeded with forty minutes of debate on H.R. 815.
