Sets forth the rule for consideration of H.R. 3773 (Responsible Electronic Surveillance That is Overseen, Reviewed, and Effective Act of 2007, or RESTORE Act of 2007).

Actions Timeline

- **Nov 15, 2007:** Considered as privileged matter. (consideration: CR H13969)
- **Nov 15, 2007:** DEBATE - The House proceeded with one hour of debate on H. Res. 824.
- **Nov 15, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 824, the Chair put the question on ordering the previous question and by voice vote, announced that the yeas had prevailed. Mr. Hastings (WA) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question and subsequent adoption of H. Res. 824 until later in the legislative day.
- **Nov 15, 2007:** Considered as unfinished business. (consideration: CR H13977-13978)
- **Nov 15, 2007:** On ordering the previous question Agreed to by the Yeas and Nays: 221 - 195 (Roll no. 1110). (consideration: CR H13975-13976, H13977)
