Summary (as of Mar 6, 2007)

Expresses the sense of Congress that: (1) state and local government agencies should be supported for taking actions to discourage illegal immigration; (2) current laws governing immigration enforcement should be enforced to the highest extent of the law; and (3) enhanced border security and enforcement legislation should be passed quickly in order to ease the burden on state and local government agencies.

Actions Timeline

- Mar 19, 2007: Referred to the Subcommittee on Immigration, Citizenship, Refugees, Border Security, and International Law.
- Mar 6, 2007: Introduced in House
- Mar 6, 2007: Referred to the Committee on the Judiciary, and in addition to the Committee on Homeland Security, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
