## Summary (as of Feb 6, 2007)

Midwifery Care Access and Reimbursement Equity Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to provide for the coverage of and payment for certified midwife services. (Currently only certified nurse-midwife services are covered.)

## Actions Timeline

- **Feb 20, 2007:** Referred to the Subcommittee on Health.
- **Feb 7, 2007:** Referred to the Subcommittee on Health.
- **Feb 6, 2007:** Introduced in House
- **Feb 6, 2007:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
