Summary (as of Feb 7, 2007)

Dog and Cat Fur Prohibition Enforcement Act - Amends provisions of the Tariff Act of 1930 that prohibit the importation of dog or cat fur to modify the definitions of "cat fur" and "dog fur" to include the pelt or skin of the domestic cat or dog, respectively.

Amends the Fur Products Labeling Act to expand the definition of "fur product" to include all fur as defined by such Act regardless of the quantity used.

Actions Timeline

- **Feb 20, 2007:** Referred to the Subcommittee on Trade.
- **Feb 8, 2007:** Referred to the Subcommittee on Commerce, Trade and Consumer Protection.
- **Feb 7, 2007:** Introduced in House
- **Feb 7, 2007:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
