Condemns the assassination of former Pakistani Prime Minister Benazir Bhutto and expresses condolences to her family and the families of all those who were killed or injured in the attack.

Welcomes the United Kingdom's assistance in the investigation of the attack and commends Pakistan for accepting such assistance.

Reaffirms the U.S. commitment to assist the people of Pakistan in combating terrorist activity and promoting a free and democratic Pakistan.
