Celebrates the courage and bravery of the crew of the Challenger, and Christa McAuliffe and her passion for encouraging America's children to pursue careers in science and mathematics.

Commits the House of Representatives and the Nation to using the lessons learned in inquiries into the space shuttle Challenger accident to ensure that the space agency always operates on a strong and stable foundation.

Recognizes the continued dedication of the United States to the goal of space exploration for the benefit of all mankind.

Actions Timeline

- **Feb 6, 2008:** Mr. Melancon moved to suspend the rules and agree to the resolution.
- **Feb 6, 2008:** Considered under suspension of the rules. (consideration: CR H571-573)
- **Feb 6, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 943.
- **Feb 6, 2008:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Feb 6, 2008:** Considered as unfinished business. (consideration: CR H593)
