- **Feb 26, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 974, Mr. Hastings of Florida moved the previous question on adoption of the resolution and by voice vote, the Chair announced that the ayes had prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.

- **Feb 26, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 212 - 198 (Roll no. 73). (consideration: CR H1044, H1044-1045)

- **Feb 26, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 12, 2008:** Introduced in House
- **Feb 12, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-524, by Ms. Sutton.
