Agreed to without objection.

- **Feb 25, 2008:** DEBATE - Pursuant to a previous special order, the House proceeded with ten minutes of debate on H. Res. 989.

- **Feb 25, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H1016)
