- **Jan 20, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1017.
- **Jan 20, 2010:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1017, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Jan 20, 2010:** Considered as unfinished business. (consideration: CR H229-230)
- **Jan 20, 2010:** On ordering the previous question Agreed to by the Yeas and Nays: 239 - 175 (Roll no. 9). (consideration: CR H210, H229-230)
- **Jan 20, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H206-207)
- **Jan 20, 2010:** On agreeing to the resolution Agreed to by voice vote. (text: CR H206-207)
- **Jan 20, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 19, 2010:** Introduced in House
- **Jan 19, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-399, by Mr. McGovern.
- **Jan 19, 2010:** Each bill is allowed 1 hour of general debate. Previous question shall be considered as ordered, in each instance, without intervening motions except motion to recommit with or without instructions. Measures will be considered read. Specified amendments are in order, in each instance. The amendment in the nature of a substitute recommended by the Committee on Natural Resources, in each instance,
