- **Feb 23, 2010:** On motion to suspend the rules and agree to the resolution Agreed to by the Yeas and Nays: (2/3 required): 408 - 0 (Roll no. 54). (text: CR 2/22/2010 H617)
- **Feb 23, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 22, 2010:** Mr. Lynch moved to suspend the rules and agree to the resolution.
- **Feb 22, 2010:** Considered under suspension of the rules. (consideration: CR H617-618)
- **Feb 22, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1039.
- **Feb 22, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Lynch objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
