## Summary (as of Feb 23, 2010)

**(This measure has not been amended since it was introduced. The summary of that version is repeated here.)**

Recognizes the significance of Black History Month as an important time to recognize the contributions of African-Americans in the nation's history.

Encourages the continued celebration of this month to provide an opportunity for all peoples of the United States to learn more about the past and to better understand the experiences that have shaped the nation.

Recognizes that the ethnic and racial diversity of the United States enriches and strengthens the nation.

- **Feb 23, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 22, 2010:** Mr. Lynch moved to suspend the rules and agree to the resolution.
- **Feb 22, 2010:** Considered under suspension of the rules. (consideration: CR H618-621)
- **Feb 22, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1046.
- **Feb 22, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Lynch objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
