- **Feb 4, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 3, 2009:** Introduced in House
- **Feb 3, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-10, by Mr. Polis (CO).
- **Feb 3, 2009:** Upon the adoption of H. Res. 107, it shall be in order to take from the Speaker's table the bill H.R. 2 with the Senate amendment thereto, and for the Chair to entertain a motion to concur in the Senate amendment. The Senate amendment and the motion shall be considered as read. The motion shall be debatable for one hour.
- **Feb 3, 2009:** Placed on the House Calendar, Calendar No. 7.
