Summary (as of Mar 4, 2010)

Recognizes the importance of the 2010 Census and encourages full participation.

Encourages each community within Indian Country to name an elder to be the first member of that community to answer the Census.

Actions Timeline

- **Mar 4, 2010:** Mr. Baca moved to suspend the rules and agree to the resolution.
- **Mar 4, 2010:** Considered under suspension of the rules. (consideration: CR H1109-1112)
- **Mar 4, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1086.
- **Mar 4, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Baca objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Mar 4, 2010:** Considered as unfinished business. (consideration: CR H1113-1114)
- **Mar 4, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 415 - 1, 1 Present (Roll no. 85).(text: CR H1109)
- **Mar 4, 2010:** On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 415 - 1, 1 Present (Roll no. 85). (text: CR H1109)
- **Mar 4, 2010:** Motion to reconsider laid on the table Agreed to without objection.
