Summary

Expresses support for the designation of Census Awareness Month.

Encourages individuals to participate in the 2010 Census beginning April 1, 2010, and urges state, local, county, and tribal governments and other organizations to emphasize its importance.

Actions Timeline

- **Mar 3, 2010:** Mr. Lynch moved to suspend the rules and agree to the resolution, as amended.
- **Mar 3, 2010:** Considered under suspension of the rules. (consideration: CR H1035-1037)
- **Mar 3, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1096.
- **Mar 3, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Lynch objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Mar 3, 2010:** Considered as unfinished business. (consideration: CR H1046-1047)
- **Mar 3, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution, as amended Agreed to by recorded vote (2/3 required): 409 - 1, 1 Present (Roll no. 80).(text: CR H1035)
