Declares that the House of Representatives continues to work with the engineering community to ensure that the creativity and contributions made by engineers can be expressed through research, development, standardization, and innovation.

Actions Timeline

- **Mar 2, 2010:** Mr. Wu moved to suspend the rules and agree to the resolution.
- **Mar 2, 2010:** Considered under suspension of the rules. (consideration: CR H984-987)
- **Mar 2, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1097.
- **Mar 2, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Wu objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Mar 2, 2010:** Considered as unfinished business. (consideration: CR H1000-1001)
- **Mar 2, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 382 - 0 (Roll no. 77).(text: CR H984)
