## Summary (as of Mar 4, 2010)

Honors Theodor Geisel (Dr. Seuss) for his success in encouraging children to discover the joy of reading.

Honors the 13th anniversary of Read Across America Day, which occurs on March 2, 2010.

Encourages parents to read with their children for at least 30 minutes on Read Across America Day.

- **Mar 4, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 414 - 0 (Roll no. 86).(text: CR 3/2/2010 H997-998)
- **Mar 4, 2010:** On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 414 - 0 (Roll no. 86). (text: CR 3/2/2010 H997-998)
- **Mar 4, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 2, 2010:** Mr. Courtney moved to suspend the rules and agree to the resolution.
- **Mar 2, 2010:** Considered under suspension of the rules. (consideration: CR H997-999)
- **Mar 2, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1111.
- **Mar 2, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Courtney objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Feb 25, 2010:** Introduced in House
- **Feb 25, 2010:** Referred to the House Committee on Education and Labor.
