- **Jun 10, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 9, 2010:** Ms. Chu moved to suspend the rules and agree to the resolution.
- **Jun 9, 2010:** Considered under suspension of the rules. (consideration: CR H4269-4270)
- **Jun 9, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1121.
- **Jun 9, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Ms. Chu objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.

- **Feb 25, 2010:** Introduced in House
