Summary (as of Mar 2, 2010)

Sets forth the rule for consideration of the bill (H.R. 4247) to prevent and reduce the use of physical restraint and seclusion in schools.

Actions Timeline

- **Mar 3, 2010:** Considered as privileged matter. (consideration: CR H1037-1043)
- **Mar 3, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1126.
- **Mar 3, 2010:** The previous question was ordered without objection. (consideration: CR H1043)
- **Mar 3, 2010:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1126, the Chair put the question on agreeing to the resolution and by voice vote, announced that the ayes had prevailed. Ms. Foxx demanded the yeas and nays and the Chair postponed further proceedings on agreeing to the resolution until later in the legislative day.
- **Mar 3, 2010:** Considered as unfinished business. (consideration: CR H1045-1046)
- **Mar 3, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 184 (Roll no. 78).(text: CR H1037-1038)
- **Mar 3, 2010:** On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 184 (Roll no. 78). (text: CR H1037-1038)
- **Mar 3, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 2, 2010:** Introduced in House
- **Mar 2, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-425, by Mr. Cardoza.
- **Mar 2, 2010:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The amendment in the nature of a substitute recommended by the Committee on Education and Labor now printed in the bill shall be considered as adopted. It shall be in order at any time through the legislative day of March 4, 2010, for the Speaker to entertain motions that the House suspend the rules. The requirement of clause 6(a) of rule XIII for a two-thirds vote to consider a report from the Committee on Rules on the same day it is presented to the House is waived with respect to any resolution reported through the legislative day of March 4, 2010.
- **Mar 2, 2010:** Placed on the House Calendar, Calendar No. 168.
