Recognizes the 150th anniversary of the birth of Will Keith Kellogg and his contributions to the citizens of the United States and the people of the world.

Actions Timeline

- **May 25, 2010:** Mr. Lynch moved to suspend the rules and agree to the resolution.
- **May 25, 2010:** Considered under suspension of the rules. (consideration: CR H3773-3775)
- **May 25, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1172.
- **May 25, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Lynch objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **May 25, 2010:** Considered as unfinished business. (consideration: CR H3789-3790)
- **May 25, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 410 - 0 (Roll no. 301).(text: CR H3773)
