## Actions Timeline

- **Mar 18, 2010:** Considered as privileged matter. (consideration: CR H1600-1605)
- **Mar 18, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1190.
- **Mar 18, 2010:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1190, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mrs. Foxx demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Mar 18, 2010:** Considered as unfinished business. (consideration: CR H1609-1611)
- **Mar 18, 2010:** On ordering the previous question Agreed to by the Yeas and Nays: 222 - 203 (Roll no. 129). (consideration: CR H1610)
- **Mar 18, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 232 - 187 (Roll no. 130). (text: CR H1600)
- **Mar 18, 2010:** On agreeing to the resolution Agreed to by recorded vote: 232 - 187 (Roll no. 130). (text: CR H1600)
- **Mar 18, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 17, 2010:** Introduced in House
- **Mar 17, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-441, by Mr. McGovern.
- **Mar 17, 2010:** The resolution authorizes the Speaker to entertain motions that the House suspend the rules at any time through the Calendar day of March 21, 2010. The resolution also provides that the Speaker or her designee shall consult with the Minority Leader or his designee on the designation of any matter for consideration under suspension of the rules pursuant to the resolution.
- **Mar 17, 2010:** Placed on the House Calendar, Calendar No. 174.
