Summary (as of Mar 25, 2010)

Sets forth the rule for consideration of the Senate amendments to the bill (H.R. 4872) to provide for reconciliation pursuant to Title II of the concurrent resolution on the budget for fiscal year 2010 (S.Con.Res. 13).

Actions Timeline

- **Mar 25, 2010:** Introduced in House
- **Mar 25, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-458, by Ms. Slaughter.
- **Mar 25, 2010:** The resolution makes in order a motion offered by the chair of the Committee on Education and Labor that the House concur in the Senate amendments to H.R. 4872. The previous question shall be considered as ordered without intervening motion or demand for division of the question. The resolution provides 10 minutes of debate on the motion. The resolution waives all points of order against consideration of the motion except those arising under clause 10 of rule XXI.
- **Mar 25, 2010:** Placed on the House Calendar, Calendar No. 182.
- **Mar 25, 2010:** Considered as privileged matter. (consideration: CR H2418-2429)
- **Mar 25, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1225.
- **Mar 25, 2010:** The previous question was ordered without objection. (consideration: CR H2428)
- **Mar 25, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 225 - 199 (Roll no. 193). (text: CR H2418-2419)
- **Mar 25, 2010:** On agreeing to the resolution Agreed to by the Yeas and Nays: 225 - 199 (Roll no. 193). (text: CR H2418-2419)
- **Mar 25, 2010:** Motion to reconsider laid on the table Agreed to without objection.
