Ms. Foxx demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until a time to be announced.

- **Apr 15, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 235 - 171 (Roll no. 204).(text: CR H2585)

Notwithstanding clause 11 of rule XVIII, no amendment to the bill shall be in order except those printed in the report of the Committee on Rules accompanying this resolution. All points of order against such amendments are waived except those arising under clause 9 or 10 of rule XXI.
