### Summary

 (as of Apr 15, 2010)

Requires the Committee on Standards of Official Conduct to report to the House of Representatives, with respect to the activities addressed in its report of February 26, 2010 (regarding possible connections between PMA Group campaign contributions and specific earmarks), on: (1) how many witnesses were interviewed; (2) how many, if any, subpoenas were issued in the course of their investigation; and (3) what documents were reviewed and their availability for public review.

## Actions Timeline

- **Apr 15, 2010:** Introduced in House
- **Apr 15, 2010:** Referred to the House Committee on Standards of Official Conduct.
- **Apr 15, 2010:** QUESTION OF THE PRIVILEGES OF THE HOUSE - Mr. Flake rose to a question of the privileges of the House and offered a previously noticed privileged resolution. The Chair announced that the resolution qualified and directed the Clerk to report the resolution to the House.
- **Apr 15, 2010:** Considered as privileged matter. (consideration: CR H2609-2610)
- **Apr 15, 2010:** Mr. Oberstar moved to refer to Standards of Official Conduct.
- **Apr 15, 2010:** DEBATE - The Chair recognized Mr. Oberstar to proceed with up to one hour of debate on the motion to refer H.Res. 1255 to the Committee on Standards of Official Conduct.
- **Apr 15, 2010:** The previous question was ordered without objection. (consideration: CR H2610)
