Summary (as of Jun 22, 2009)

Enumerated Powers Act - Requires each Act of Congress to contain a concise explanation of the specific constitutional authority relied upon for the enactment of each portion of that Act. Declares that failure to comply with this requirement shall give rise to a point of order in either chamber of Congress.

Specifies procedures for disposition of such point of order in the Senate.

- **Jun 22, 2009:** Introduced in Senate
- **Jun 22, 2009:** Read twice and referred to the Committee on Rules and Administration. (CR S6933-6934)
