Summary (as of Jun 23, 2010)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Expresses support for the goals and ideals of National Hurricane Preparedness Week.

Encourages the staff of the National Oceanic and Atmospheric Administration (NOAA), especially the National Weather Service and the National Hurricane Center, and other appropriate federal agencies to continue their outstanding work of educating people about hurricane preparedness.

Urges the people of the United States to recognize such week as an opportunity to learn more about the Center's work in forecasting hurricanes and educating citizens about the potential risks of the storms.

- **Jun 23, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 22, 2010:** Mr. Carnahan moved to suspend the rules and agree to the resolution.
- **Jun 22, 2010:** Considered under suspension of the rules. (consideration: CR H4649-4651)
- **Jun 22, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1388.
- **Jun 22, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Carnahan objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.

- **May 24, 2010:** Referred to the House Committee on Science and Technology.
