Summary (as of Jan 6, 2009)

Haitian Protection Act of 2009 - Requires the Secretary of Homeland Security to designate Haiti as a country whose qualifying nationals may be eligible for temporary protected status.

Provides for: (1) an initial 18-month designation period; and (2) authorization for temporary travel abroad.

Actions Timeline

- **Feb 9, 2009:** Referred to the Subcommittee on Immigration, Citizenship, Refugees, Border Security, and International Law.
- **Jan 6, 2009:** Introduced in House
- **Jan 6, 2009:** Sponsor introductory remarks on measure. (CR E16)
- **Jan 6, 2009:** Referred to the House Committee on the Judiciary.
