Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to allow consideration of any resolution reported from the Committee on Rules through the legislative day of July 23, 2010, providing for consideration or disposition of a measure addressing unemployment compensation, on the same day it is presented to the House.

- **Jul 20, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-552, by Mr. Hastings (FL).
- **Jul 20, 2010:** The resolution waives clause 6(a) of rule XIII (requiring a two-thirds vote to consider a rule on the same day it is reported from the Rules Committee) against certain resolutions reported from the Rules Committee. The resolution also authorizes the Speaker to entertain motions that the House suspend the rules at any time through the legislative day of July 23, 2010.
- **Jul 20, 2010:** Placed on the House Calendar, Calendar No. 221.
