Sets forth the rule for consideration of the Senate amendment to the House amendment to the Senate amendment to the bill (H.R. 4213) to amend the Internal Revenue Code of 1986 to extend certain expiring provisions.

Actions Timeline

- **Jul 22, 2010:** Introduced in House
- **Jul 22, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-556, by Mr. Hastings (FL).
- **Jul 22, 2010:** The resolution makes in order a motion offered by the chair of the Committee on Ways and Means that the House concur in the Senate amendment to the House amendment to the Senate amendment to H.R. 4213. The resolution waives all points of rorder against consideration of the motion except those arising under clause 10 of rule XXI and that the Senate amendment shall be considered as read.
- **Jul 22, 2010:** Placed on the House Calendar, Calendar No. 223.

- **Jul 22, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1550.
