Sets forth the rule for consideration of the bill (H.R. 5893) to amend the Internal Revenue Code of 1986 to create jobs through increased investment in infrastructure, to eliminate loopholes which encourage companies to move operations offshore.

Actions Timeline

- **Jul 29, 2010:** Considered as privileged matter. (consideration: CR H6297-6306)
- **Jul 29, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1568.
- **Jul 29, 2010:** The previous question was ordered without objection. (consideration: CR H6306)
- **Jul 29, 2010:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1568, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Ms. Foxx demanded the yeas and nays, and the Chair postponed further proceedings on adoption of the resolution until later in the legislative day.
- **Jul 29, 2010:** Considered as unfinished business. (consideration: CR H6308-6309)
- **Jul 29, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 233 - 182 (Roll no. 486). (text: CR H6297)
- **Jul 29, 2010:** On agreeing to the resolution Agreed to by the Yeas and Nays: 233 - 182 (Roll no. 486). (text: CR H6297)
- **Jul 29, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 28, 2010:** Introduced in House
- **Jul 28, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-577, by Mr. Hastings (FL).
- **Jul 28, 2010:** All points of order against consideration of the bill except those arising under clause 9 or 10 of rule XXI are waived. The resolution waives clause 6(a) of rule XIII against any resolution reported from the Rules Committee through the calendar day of Sunday, August 1, 2010 (same day filing).
- **Jul 28, 2010:** Placed on the House Calendar, Calendar No. 227.
