- **Sep 16, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 15, 2010:** Mr. Clay moved to suspend the rules and agree to the resolution.
- **Sep 15, 2010:** Considered under suspension of the rules. (consideration: CR H6704-6706)
- **Sep 15, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1612.
- **Sep 15, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Clay objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
