Summary (as of Mar 19, 2009)

Children's Health Protection Act of 2009 - Amends the Employee Retirement Income Security Act of 1974 (ERISA), the Public Health Service Act, and the Internal Revenue Code to prohibit a group health plan from imposing any preexisting condition exclusion for individuals who have not attained 25 years of age.

Applies such requirement to coverage offered in the individual market.

Actions Timeline

- **May 14, 2009:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Mar 23, 2009:** Referred to the Subcommittee on Health.
- **Mar 19, 2009:** Introduced in House
- **Mar 19, 2009:** Referred to House Energy and Commerce
- **Mar 19, 2009:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Education and Labor, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Mar 19, 2009:** Referred to House Education and Labor
- **Mar 19, 2009:** Referred to House Ways and Means
