Actions Timeline

- **Dec 13, 2010:** Referred to the Subcommittee on Military Personnel.
- **Nov 30, 2010:** Mr. Garamendi moved to suspend the rules and agree to the resolution.
- **Nov 30, 2010:** Considered under suspension of the rules. (consideration: CR H7696-7698)
- **Nov 30, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1740.
- **Nov 30, 2010:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Rogers (AL) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Nov 30, 2010:** Considered as unfinished business. (consideration: CR H7703)
- **Nov 30, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 404 - 0 (Roll no. 586).(text: CR H7696)
