Sets forth the rule for consideration of the joint resolution (H.J. Res. 101) making further continuing appropriations for fiscal year 2011.

Actions Timeline

- **Dec 1, 2010:** Considered as privileged matter. (consideration: CR H7763-7767)
- **Dec 1, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1741.
- **Dec 1, 2010:** The previous question was ordered without objection. (consideration: CR H7766)
- **Dec 1, 2010:** POSTPONED PROCEEDINGS - At conclusion of debate on H.Res. 1741, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day.
- **Dec 1, 2010:** Considered as unfinished business. (consideration: CR H7774-7775)
- **Dec 1, 2010:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 236 - 172 (Roll no. 589).(text: CR H7763)

- **Dec 1, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 30, 2010:** Introduced in House
- **Nov 30, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-664, by Mr. Polis (CO).
- **Nov 30, 2010:** All points of order against consideration of the joint resolution are waived except those arising under clause 9 or 10 of rule XXI. All points of order against provisions in the joint resolution are waived.
- **Nov 30, 2010:** Placed on the House Calendar, Calendar No. 247.
