Sets forth the rule for consideration of the Senate amendment to the bill (H.R. 3082) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2010.

Actions Timeline

- **Dec 8, 2010:** The House Committee on Rules reported an original measure, H. Rept. 111-675, by Mr. McGovern.

- **Dec 8, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1755.
- **Dec 8, 2010:** The resolution makes in order a motion to concur in the Senate amendment to H.R. 3082. It waives all points of order against consideration of the motion. The resolution provides that the Senate amendment and the motion shall be considered as read.
- **Dec 8, 2010:** The previous question was ordered without objection. (consideration: CR H8150)
