- **Dec 8, 2010:** DEBATE - The House proceeded with one hour of debate on H. Res. 1756.
- **Dec 8, 2010:** The rule provides for consideration of the Senate amendments to H.R. 5281. The resolution makes in order a motion by the Committee on the Judiciary that the House concur in the Senate amendments numbered 1 and 2; and that the House concur in the Senate amendment numbered 3 with an amendment printed in the report.
- **Dec 8, 2010:** The previous question was ordered without objection. (consideration: CR H8220)
- **Dec 8, 2010:** POSTPONED PROCEEDINGS - The Chair put the question on adoption of the resolution and voice vote, announced that the ayes had prevailed. Ms. Foxx demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until a time to be announced.
