Summary (as of Apr 2, 2009)

Complete America's Great Trails Act - Amends the Internal Revenue Code to allow a tax credit for the fair market value of any National Scenic Trail conservation contribution. Requires the Secretary of the Interior to study and report to Congress on the efficacy of such tax credit in completing, extending, and increasing the number of National Scenic Trails.

Actions Timeline

- **Apr 9, 2009:** Referred to the Subcommittee on National Parks, Forests and Public Lands.
- **Apr 2, 2009:** Introduced in House
- **Apr 2, 2009:** Referred to House Ways and Means
- **Apr 2, 2009:** Referred to the Committee on Ways and Means, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 2, 2009:** Referred to House Natural Resources
