## Actions Timeline

- **Mar 17, 2009:** Mr. Clay moved to suspend the rules and agree to the resolution.
- **Mar 17, 2009:** Considered under suspension of the rules. (consideration: CR H3453-3456)
- **Mar 17, 2009:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 211.
- **Mar 17, 2009:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Clay objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Mar 17, 2009:** Considered as unfinished business. (consideration: CR H3470-3471)
- **Mar 17, 2009:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by recorded vote (2/3 required): 418 - 0 (Roll no. 129).(text: CR H3453)
