Summary (as of Mar 5, 2009)

Requires the House Committee on Standards of Official Conduct, or a designated investigative subcommittee, to begin immediately an investigation and report to the House on the relationship between: (1) earmark requests on behalf of clients of the raided top defense-lobbying firm already made by Members; and (2) the source and timing of past campaign contributions related to such requests.

Actions Timeline

- **Mar 5, 2009:** Introduced in House
- **Mar 5, 2009:** QUESTION OF THE PRIVILEGES OF THE HOUSE - Mr. Flake rose to a question of the privileges of the House and offered a resolution. The Chair directed the Clerk to report the resolution. The Clerk completed the reading of H.Res. 212 and the Chair announced that the resolution met the required threshold under the rule.
