Summary (as of Dec 1, 2009)

Recognizes the 21st anniversary of observing World AIDS Day.

Expresses support for: (1) the goals and ideals of such Day; (2) continued funding for prevention, care, treatment services, and research programs for persons living with HIV/AIDS in the United States and for the President's Emergency Plan for AIDS Relief and the Global Fund to Fight AIDS, Tuberculosis, and Malaria; (3) the development of a national AIDS strategy to reduce new HIV infections, especially among vulnerable communities; (4) the goals of providing universal access to comprehensive HIV/AIDS prevention, treatment, care, and support programs and protecting human rights for all people, including vulnerable and marginalized populations; and (5) efforts to address the factors that make populations vulnerable to HIV/AIDS by decreasing poverty and hunger, expanding educational opportunities for children, and empowering women.

Actions Timeline

- **Dec 2, 2009:** Referred to the Subcommittee on Health.
- **Dec 1, 2009:** Introduced in House
- **Dec 1, 2009:** Referred to House Energy and Commerce
- **Dec 1, 2009:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Dec 1, 2009:** Referred to House Foreign Affairs
