## Summary (as of May 12, 2009)

Home Oxygen Patient Protection Act of 2009 - Amends title XVIII (Medicare) of the Social Security Act to restore Medicare payment for the rent of oxygen and oxygen equipment.

Repeals the limitation of Medicare payment to the supplier for such equipment (including portable oxygen equipment) to 36 months of continuous use.

## Actions Timeline

- **May 13, 2009:** Referred to the Subcommittee on Health.
- **May 12, 2009:** Introduced in House
- **May 12, 2009:** Referred to House Energy and Commerce
- **May 12, 2009:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 12, 2009:** Referred to House Ways and Means
